



**5/2020. (XI.07.) Instruction of the Dean for
the distance learning system in the fall semester of 2020/21 academic year
at the Faculty of Public Health**

Referring to the resolution of the Government of 478/2020. (XI. 3.) on the declared emergency, the Rector of the University of Debrecen issued a rector's instruction on 6 November 2020, on the basis of which I order in this instruction of the Dean that at the Faculty of Public Health of Debrecen **from November 9, 2020 (from the 10th week of education) the education will take the form of distance learning in all programmes.**

Based on this the lecturers hold the lectures, seminars and exercises through the Webex system integrated into the e-learning system at the scheduled time and duration. During the week of November 9, 2020 the instructor is temporarily allowed to hold the lesson by publishing materials, teaching aids, and possibly pre-recorded lessons published in the e-learning system instead of online classes.

I would like to draw your attention to the fact that the study and examination regulations, as well as the provisions on absence published at the beginning of the semester also apply to lectures, seminars and exercises held in the form of Webex, the presence is checked on the electronic interface!

Educational tasks that cannot be performed with absentee education activities or can be performed with disproportionate difficulty can still be performed with a personal presence, in full compliance with epidemiological regulations, and, if possible, in blocks. In the case of such practice-intensive subjects, the practices will be rescheduled from 9 November, so from the 10th week. Regarding the block completion of the exercises starting from the 11th week, Annex 1 of this Dean's instruction is provided, which will be published electronically in the 10th week.

Students of the Faculty of Public Health are not allowed to visit the buildings of the University of Debrecen in the 10th week and there is no possibility of personal administration. From the 11th week onwards, visits to the University's buildings are permitted only for the purpose of completing the practical subjects specified in Annex 1 to these instructions, in accordance with the published schedule.

Questions about each subject shall be asked through the e-learning interface in the *Student Forum* menu after making sure that the question has not been answered before. Questions received through the student forum are answered by instructors involved in the teaching of the subject.



The staff of the Educational Office will continue to carry out the educational administration of the students through the Neptun system, therefore, with such questions and requests, please contact your academic registrar with confidence at the following electronic contacts.
